I would like to thank you for the opportunity to present to the Section 80 Technical Services Committee of the Mkhondo Local Municipality on 14/03/2023 and to the Council Meeting on

30/03/2023.

The Council has adopted our presentation and tasked the Acting Municipal Manager, to conduct a due diligence on the proposed initiative for electrical services and to provide a report with recommendations to the following Council Meeting so that the Council can take a decision

on the proposed initiative (Resolution 23/03/108A).

We proposed to Council that the Mkhondo Local Municipality should:

1. Instruct the Accounting Officer to conduct a Section 77 review of the Electrical Service

Delivery Mechanisms of the Local Municipality.

2. Appoint Zahara & Company as Pro-Bono Transaction Advisors to assist the

Accounting Officer with the Review Process in terms of Section 76-81 of the Municipal

Systems Act and Regulation 16 of the Public Finance Management Act.

3. Adopt the COGTA Small Town Regeneration Strategy as a mechanism for

strengthening the Public Participation Process.

- 1. Register a Public Private Partnership at National Treasury and the Dep. of COGTA
- 2. Facilitate all Public Participation Processes.
- 3. Conduct a Feasibility Study for Electrical Services as part of the Review Process (TA:I)
- 4. Conduct a Formal Bidding Process in collaboration with the Administration (TA:IIA&B)
- 5. Conclude the Contracting Process with the Preferred Bidder (TA:III)
- 6. Commission the Project in collaboration with all Stakeholders.
- 7. Provide a Close-out Report with all the supporting documents and approvals.

We understand that the Mkhondo Local Municipality cannot afford to pay the consulting fees

debt relief initiative, the compliance conditions on the Mkhondo Local Municipality are severe:

The Ring-fencing of Basic Service Accounts

A Funded MTREF Budget

The Alignment between the Billing System and the General Valuation Roll

An 85% Collection Rate for all Rates & Taxes by 01 April 2024

• The full payment of the Monthly Eskom Bulk Current Account.

• The enforcement of a Debt Relief Limit for three years.

According to Notice 124, the non-compliance of these requirements may force National

Treasury to either take over the electricity business of the Municipality, or to apply to NERSA

to revoke the electrical service license of the Municipality - this is not in the best interest of

the Municipality.

The adoption of our proposal to review the electrical services business of the Municipality and

to research the feasibility of external electrical service delivery mechanisms might enable the

Municipality to comply with the requirements of National Treasury by the end of 2024.
