Mkhondo Local Municipality, hereby invites local civil works service providers registered with **CIDB Grading of 1CE / 1GB and 2CE / 2 GB only** to submit their offers for the **Construction of Dignified Sanitation** - Local registered Co-operations are also encouraged to tender. A compulsory site meeting will be held on Friday, **25<sup>th</sup> June 2018 at 10h00** at Mkhondo Town Hall, 33 Mark Street. Tender documents will be obtained at the compulsory tender briefing on proof of a non-refundable payment of the amount of R300.00 by cash at cashier's office (Revenue Division). Duly completed tenders must be placed in a sealed envelope and clearly marked as "**Project No. MKHO01/2018/19: Construction of Dignified Sanitation**" and be submitted in the tender box located at Mkhondo Town Hall at municipality offices not later than **Tuesday, 03 July 2018 at 12H00**.

**NOTE:** *Only those tenderers who are registered with the Construction Industry Development Board (CIDB) and the Central Supplier Database (CSD) are eligible to submit tenders for this contract. The council reserves the right to appoint more than one service provider. The Council does not bind itself to accept the lowest or any tender. The Council may elect to accept only part of the successful tender. The adjudication process and the award, if an award is made, will conform to the requirements of the Supply Chain Management Regulation, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations of 2017. This bid is subject to the, Mkhondo Local Municipality Supply Chain Management policy, and the general conditions of contract for construction works (second edition) (2015). Only the version of this notice and invitation contained in the tender document shall form part of the tender. Tenders may only be submitted on the tender documentation that is issued. Tenders will be adjudicated according to the 80/20 of the Price Preferential point system and Method 4 of evaluation (Tenderers need to score a minimum of 50% score for Functionality to be valid for further evaluation).*
