Tenders will be adjudicated using Method 4 of evaluation, a minimum of **60 functionality points** must be scored for functionality for tenders to be valid for further evaluation.

According to the Municipality Supply Chain Regulations issued by the Minister of Finance in terms of Section 168 of the Municipal Finance Management Act, Act 56 of 2003, persons who are within the organs of the state, like Councillors, and other elected representatives, full time employees and other directors of the public and municipal entities are prohibited from being eligible to bid or be awarded a contract to provide any services to the municipality. The following **compulsory documents** must be accompanied with the tender, and failure to provide such documentations shall constitute automatic disqualification: **latest comprehensive CSD proof of registration, B-BBEE Status Level of contribution Certificate (no points to be allocated without proof of valid certified copy), Original Tax Clearance Certificate with valid SARS PIN, letter of good standing, CK Certificate, Current Municipal Account/Valid Lease agreement, certified shareholder's ID Copies**.
