In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the **ERADICATION OF WATER BACKLOG, DRILLING, EQUIPPING AND ELECTRIFICATION OF BOREHOLES IN RURAL VILLAGES OF MKHONDO LOCAL MUNICIPALITY. CLUSTER 3 (WARD 9 AND 15).**

Bid documents will be available as from **17 September 2024**, at the Cash Point by the Cashiers at Mkhondo Local Municipality offices only, upon payment of a non-refundable deposit of **R1500,00**.

The closing time for receipt of tenders is **12:00hrs** on **09/10/2024**. Telegraphic, facsimile, e-mail, unmarked and late tenders will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be opened in public. **A compulsory briefing session will be held on the 17/09/2024, at 11h00, at Piet Retief Town Hall**

Fully completed tender documents, clearly marked Tender No. **MKH06/2024/25: "ERADICATION OF WATER BACKLOG, DRILLING, EQUIPPING AND ELECTRIFICATION OF BOREHOLES IN RURAL VILLAGES OF MKHONDO LOCAL MUNICIPALITY. CLUSTER 3 (WARD 9 AND 15)"** must be placed in a sealed envelope and placed in the tender box provided by **Mkhondo Local Municipality, No. 33 Corner Market and De Wet Street, eMkhondo, 2380, by no later than the 09th of October on closing date**. The envelope must be endorsed with number, title and closing date as indicated above.

The Tender can only be submitted on the documentation that is issued. Supporting and additional documentation are welcomed as outlined. Bidders are expected to score a minimum score of **70%** for Functionality under Stage Two Evaluation to be considered for the third stage of evaluation. All submissions will be adjudicated in terms of the Mkhondo Local Municipality's Procurement Policy and Bids will be evaluated in accordance with Preferential Procurement Policy Framework Act no 5 of 2000 as well as the Preferential Procurement Regulations, 2022 (PPR2022). The 80/20 Price and Specific goals Point System will be applicable for this Tender. Mkhondo Local Municipality Supply Chain Management Policy allocate 20 points in terms of

specific goals as follows:

- 100% Black person or people owned enterprise **(2 points)**
- More than 30% people living with disability shareholding or owned enterprise **(2 points)**,
- More than 30% Youth Shareholding or owned enterprise **(2 points)**
- More than 30% woman or women shareholding or owned enterprise **(2 points)**
Enterprise located within Mkhondo Local area of jurisdiction **(2 points)**
- Points for valid B-BBEE Level 1 contribution (SANAS verified B-BBEE certificate for generic enterprise, and for EME and SME a sworn affidavit or CIPC issued certificate confirming annual turnover and level of Black Ownership B-BBEE Level **(3 points)**)
- Enterprise who will sub-contract minimum of 30% of the contract value to EMEs in the ward or local communities where the services to be rendered or works to be undertaken **(2 points)**
- Corporate Social Investment (CSI) or Social Labour Plan proposition **(5 points)**

No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

Bidders that do not hear anything after three (3) months from closing date of this tender must consider their bids as unsuccessful.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

The following documents must be attached (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- Copy/ printed Tax compliance status Pin to enable the municipality to verify the bidder's tax compliance status- **Compulsory**
- Copy of bidder's or director's current municipal account or copy of valid Lease Agreement – **Compulsory**
- Valid full comprehensive CSD registration report (not a summary)– **Compulsory**
- Audited Annual Financial Statements for the past 3 years, for companies required by law to submit annual financial statements - **Compulsory**.
- Valid CIDB Certificate 7CE or Higher – **Compulsory**
- Valid COIDA (Letter of Good Standing) certificate from the Department of Labour – **Compulsory**
- Copy of Company registration certificate and Certified copies of IDs of Directors - **Compulsory**
