The 80/20 Preference Point System will be applicable for this RFQ where 80 points will be allocated for price and 20 points shall be allocated for specific goals. A total of 15 preference points shall be allocated on a proportional or pro rata basis for contracting an enterprise owned by historically disadvantaged persons or individuals who meet the following requirements and a total of 5 preference points shall be allocated on a proportional or pro rata basis for implementing of programme for RDP (Reconstruction and Development Programme).
